NATURE OF WORK:

The employee teaches students in the Bilingual Education Program in any assigned grade level within the grades K-8 in any of the 20 public schools that the bilingual instruction is implemented. The job would require bilingual certification and the employee must take all the seven required bilingual courses. The employee will be collaborating with the CCLHS Program Managers as well as his or her immediate supervisor and the school principal in providing valuable information for student cognitive growth in the bilingual standard and benchmarks.

DUTIES AND RESPONSIBILITIES:

These are intended only as illustrations of the various types of work performed. The omission of specific duties does not exclude them from the position if the work is similar, related, or a logical assignment to the position.

- The employee must be knowledgeable in preparing bilingual lesson plan based on the approved Bilingual Education Standard and Benchmarks
- Able to manage students in the classroom
- Prepare effective classroom rules
- Able to communicate to parents and administrators
- Able to relate classroom lessons to current events and appropriate references
- Able to use manipulative and related hands-on instructional materials

FORTY (40) HOUR WORKWEEK:

The normal work period shall be a seven (7) days work period with a maximum non-overtime of forty (40) hours.

The Public School System (PSS) operates on a 40-hour work week. Actual working hours will be determined on the basis of operational efficiency. School Principals, Supervisors or Program Managers will establish working schedules subject to the approval of the Commissioner of Education.

ESSENTIAL FUNCTION OF THE JOB:

The duties and responsibilities listed herein have excluded the functions of the position that are incidental to the performance of fundamental job duties. All duties and responsibilities listed herein are essential job functions and requirements and are subject to modification to reasonably accommodate individuals with disabilities. To perform this job successfully, the incumbent(s) will possess the skills, aptitudes, and abilities to perform each duty proficiently. - Classroom Instructor is considered “EXEMPT STATUS”: Is not eligible for overtime pay or compensatory time and is paid on a salary basis pursuant to Regulations for PSS Employment of Certified Personnel and Fair Labor Standards Act.

KNOWLEDGE, SKILLS AND ABILITIES (KSAs)

- Thorough knowledge of prescribed School Board policies, procedures, rules and regulations;
- Ability to motivate others to reach their fullest potential;
- Ability to establish and maintain effective working relationships with school officials, students, parents, teachers, support staff, associates, external organizations/companies, federal and local agency representatives.
- Awareness of and sensitivity to cultural and local community practices and norms.
- Good interpersonal and communication skills. Communicate effectively both orally and in writing, including giving and receiving feedback
- Ability to work as part of a team. Strong staff collaboration is a standard at the PSS.
- Excellent Office Automation Skills (Microsoft Word, Excel, Outlook)
- Excellent Oral & Written Skills
- Excellent Record Keeping Skills
- Knowledgeable on federal and local laws protecting the privacy of student data, including but not limited to the Family Educational Rights and Privacy Act (FERPA) 20 U.S.C. Sec. 1232g; 34 CFR Part 99, and Student Educational Records § 60-20-428 of the CNMI Public School System’s Rules and Regulations.
